It has excellent chemical and temperature resistance and provides superior performance in water treatment equipment. It is FDA compliant as per 21CFR177.2600. Operating temperature range is from 50°F (10°C) to 185°F (85°C)

- Cured Durometer Shore A Durometer of top surface: 80 ± 5. Shore D Durometer of top surface: 30 ± 5.

ADHESIVE NOTES:

See Section 6 of the Polycorp Rubber Lining Application Manual for specific cementing / adhesion notes. For proper adhesion, temperatures must be over 60°F (15°C) and must not exceed 120°F (49°C). Use adhesives in well ventilated area and always consult

the material safety data sheet for specific precautions.

CURING:

Cure time adjustments may be required to compensate for specific conditions. See Section 10 of the Application Manual for detailed instructions. All recommendations below are for lining thicknesses up to 1/4".

Autoclave Method – 3/16" & 1/4" thickness: Slow rise to 250°F/121°C (15 psi). Hold 2 1/2 hours at 250°F/121°C (15 psi). Cool down under pressure.

Internal Steam Method - 3/16" & 1/4" thickness: Slow rise to 250°F/121°C (15 psi). Hold 5 hours at 250°F/121°C (15 psi). Cool down under pressure.

Atmospheric Steam Method - Up to 1/4" thickness: Minimum 24 hours at 212°F/100°C. Lower durometer readings may result with this type cure.

STORAGE:

Store in a cool and dry area.
